Personal advice on work and income

We answer all your questions relating to your CAO, pay or benefit schemes. You can also call on us for advice about your job or career.

Legal aid in the event of physical injury or occupational illness

You are legally entitled to compensation if someone else is responsible for you suffering an accident or illness (a medical error, abuse, or poor working conditions, for example). We help you to claim that compensation.

Legal aid in the field of work and income

Are you encountering problems with your superior or anticipating dismissal? We try to solve the problem in collaboration with your employer. Sometimes we do not succeed, in which case you may need legal aid. We can provide this.

Cheap health insurance

The Dutch FNV Trade Union Federation (Federatie Nederlandse Vakbeweging, or FNV for short) offers all its 1.2 million members a favourable collective health insurance, with discounts on the mandatory basic policy as well as on supplementary packages. For this purpose, FNV has entered into a collaborative relationship with Menzis, one of the largest health insurers in the Netherlands.

Tax advice

Our members do not need to complete their own tax forms, because they can call on the staff of FNV Belastingsservice for help. This is not only easy but also saves you a lot of time.

Career-related advice and training

Our consultants can provide practical tips if you would like to make a career advancement, or need help with a job application.

Membership costs

Membership rates for 2008

FNV Bondgenoten membership costs a maximum of € 15.20 a month. This fee is reviewed annually. Special membership rates apply to young people, retired employees and non-workers up to age 65***. If your CAO includes a tax provision covering union membership fees, you may well qualify for a 40% discount. Check this with your employer.

These membership rates apply if you authorise the union to receive direct-debit payment (automatische incasso) of your monthly membership fees from your account. With other forms of payment you are not entitled to the € 0.20 discount.

- > Pupils and students are eligible for free membership during the first year.
- > You will never pay more than 1% of your gross, monthly salary in contributions, with a minimum of € 2.75 a month (€ 2.55 in the case of direct debit). Please, refer to www.fnvbondgenoten.nl for more information.
